9. Matters requiring action

9.1 Authorization application to sever the property located at 232 Nelson Street East

Whereas the application for authorization received from the United Counties of Prescott and Russell N° B-032-2022, for the property located at 232 Nelson Street East reflects the intentions of the Provincial Policy Statement, and;

Whereas the applications are consistent with the Official Plan of the United Counties of Prescott and Russell, and;

Whereas the applications comply with the intentions of the Official Plan of the Corporation of the Town of Hawkesbury and Zoning By-law N° 20-2018.

Be it resolved to support said application for authorization under section 53(1) of the *Planning Act*, R.S.O. 1990, as recommended in 2022_REC_33.

9.2 Draft Subdivision Plan Conditions Approval – The Mont Roc Project, GD Holding Ltd.

Councillor Robert Lefebvre mentions the importance of assessing if the development is conducive to the area where the development is proposed and not just following the provincial plan. He is worried about the density of the project and the lack of a single-family home in the proposal, which he thinks should be higher. He is also worried about the zoning by-law which allows having a semi-detached unit and having a secondary unit on the property; two semi-detached units could potentially become a quadruplex while respecting the town's zoning regulations. He understands the need for housing but also understands the concerns of citizens. He, therefore, has difficulty adopting this resolution due to the lack of information. According to Mr. Lefebvre, we must keep development appropriate for the region and not just follow the plan of the province.

Councillor Lawrence Bogue believes that this kind of development would be good for the town and for the United Counties of Prescott and Russell. He is in favor of adopting the proposal as presented.

Councillor Raymond Campbell agrees with the concerns presented by Mr. Lefebvre. He would have liked to see more single-family homes offered in the project, which would back up the existing single-family homes. Councillor André Chamaillard is also concerned about the permission of the zoning by-law which allows a second rental unit.

Whereas full application for approval of the Preliminary Plan of Subdivision was received by the United Counties of Prescott and Russell on January 31, 2022, and;

Whereas the public meeting required by section 51 of the Planning Act, R.S.O. 1990, as amended, was held on March 28, 2022, and;

Whereas comments from the public meeting and interested persons have been collected and are presented in this report, and;

Whereas the previous owner has already provided the equivalent of 5% of the property area for park purposes through the creation of Sidney Park, as required by the By-law N° 13-2022, and;

Whereas the project as submitted will require an amendment to Zoning By-law N° 20-2018, and;

Whereas GD Holding Ltd will have to sign a Subdivision Agreement with the Corporation of the Town of Hawkesbury as provided by Section 51 (26) of the *Planning Act*, R.S.O. 1990, as amended.

9.3 Automatic aid and mutual aid agreement with the Municipalité de Grenville-sur-la-Rouge

Whereas a Fire Master Plan was developed by the firm Pomax, and;

Whereas the Fire Safety Master Plan was submitted to Council and approved on April 12, 2021, and;

Whereas recommendation #17 of the status report is to engage in discussion with the fire departments of the region with regards to sharing resources, first response vehicles, and entering into partnerships to buy equipment, and;
