9.1 Part lot control, ref.: 1781-1783 Suzie Crescent

Whereas the applicant has requested to lift the regulation concerning the Part Lot Control By-Law under Section 50 (7) of the *Planning Act*, R.S.O. 1990, and;

Whereas the application's purpose is to divide Lot 13 of the Subdivision Plan 46M-99, being the property known under the following addresses: 1781 and 1783, Suzie Crescent, and;

Whereas these lots are part of a Subdivision Plan and respect the intentions of the Official Plan and the Corporation of the Town of Hawkesbury's Zoning By-law N° 20-2018.

Be it resolved to grant the request to lift the regulation relating to part-lot control according to subsection 50(7) of the *Planning Act*, R.S.O. 1990, for Lot 13 of registered Subdivision Plan 46M-99 and that a by-law be adopted to that effect, as recommended in the document 2022_REC_42.
