### **Achievements**

Searched for documents / subdivision agreements to respond to a drainage complaint located in the area of Pilon and Charlebois Streets.

Approval of site plans for building permit applications.

In preparation for a meeting with the landowners of the former CIP, I reviewed the Community Improvement Plan (CIP), the Municipal Act and discussions were held with Dan Ethier of the Ministry of Municipal Affairs, with Guillaume Boudrias and Philippe Timbers concerning the Financial Incentives for Brownfields.

Following the meeting with new owners of the former CIP lands, I did some research to find out if we have any environmental studies concerning the surrounding lots and if there are any lots that have a Record of Site Condition..

1. **File D02-18: Development Charges Study** Prepare and send the required studies and references for the consultant.

A meeting will be held to discuss the Town services in late May with Andrew Grunda, consultant for Watson.

2. File D08-04: Five-Year Review of the Hawkesbury Official Plan

A meeting is scheduled for late May to revise the first draft of the Plan. This first review will include the consolidation of the changes made to date, as well as, the amendments to applicable laws.

- 3. In the process of writing the Site Plan Agreement for the service station project located at 370 McGill Street.
- 4. Receipt of the full application for approval of the Harden Group Site Plan Amendment for the renovation / construction of a Retail Store (Winners) in Phase II, Commercial Center, County Road 17. The project was reviewed internally and we are in the process of writing the agreement.

### **Professional development**

Participation on April 17, 2019 in a workshop on inspections Surface Water Retention Ponds organized by the South Nation Conservation. The workshop was held in Limoges.

### Upcoming activities and projects

- The revision of the second submission of plans and specifications concerning the Ecolomondo project.
